

## **Fischgaard Short Film Project Participants Agreement**

This is an agreement between, \_\_\_\_\_(team supervisor), representing the film team known as \_\_\_\_\_, (hereafter known as "Project Participant") and the Fischgaard Short Film Project, (hereafter known as "FSFP"), with respect to Project Participant's involvement in the Fischgaard Short Film Project 2011 and creation of a short film or video (the "Film") pursuant to the terms below.

The Project Participant hereby agrees to take part in the Fischgaard Short Film Project, scheduled to take place February 18, 19 & 20 2011. Project Participant hereby states that he/she has read, and agrees to abide by, the "Official Rules of the Project," the terms of which are attached hereto and incorporated herein. It is understood that FSFP reserves the right to screen or exhibit only those films/videos that adhere to the "Official Rules of the Project."

Project Participant hereby understands that he/she is responsible for all crew, cast, equipment, sets, locations, and other items necessary for participating in the FSFP, and all costs, expenses, damages and claims related thereto. The FSFP is providing the event and guidelines in which the Project Participant is taking part; a screening opportunity for all of the completed work; and a prize for the winners.

Project Participant hereby affirms that he/she will secure all rights to images, sounds and music used in his/her project; and/or will secure talent and location releases. The Project Participant hereby affirms that he/she will secure a signed Participation Form from all cast and crew and hereby indemnifies, saves and holds harmless FSFP from any and all claims, costs, damages, expenses and liabilities arising from the creation, use or participation hereunder (including, but not limited to claims for negligence and other torts, unauthorized exhibition, discrimination, fraud, infringement and breach of contract) of Project Participant's film/video.

Project Participant hereby acknowledges that has the right to screen, show, exhibit, broadcast or disseminate in any way possible, including and not limited to theatrical release, broadcast television, cable television and/or the internet; and the right to publicize the Fischgaard Short Film Project using the name or images of the "Film."

Project Participant and FSFP hereby agree that the Project Participant retains the right to submit and screen his/her Film to film festivals. Any additional

screenings, dissemination or broadcast on the part of the Project Participant are prohibited except with the express written consent of the FSFP.

Project Participant hereby acknowledges that participation in the *Fischgaard Short Film Project 2011* is without remuneration or compensation whatsoever. The consideration for participating in the project is the screening of the participant's completed film/video at the conclusion of the project; and the possibility, although not the obligation by the FSFP, for future screenings; and the opportunity for publicity or exposure for being a participant.
